Shuttle Bus: The shuttle bus will be available on practice and game days to the first 12 players to sign up by lunch in Mrs. Enstad's room for that day's game/practice. When the shuttle bus is not available, it's each parent's responsibility to secure transportation for their child to and from practices/games.

Practices: Practices are held at Gonyea Park (13422 10th Ave. S, Parkland 98444) from 3:30pm to 5:00pm, Mondays & Wednesdays, unless there is a game scheduled. **Our first practice will be Wednesday, September 8.** Players should be picked up at Gonyea after practice at 5:00pm. Those returning to school on the shuttle bus will be escorted to Extended Care. Parents will be billed accordingly.

Uniforms: Soccer game jerseys will be provided by PLS. All jerseys, while in your care, are your responsibility. If your child's jersey is lost or ruined, you will be asked to replace it. The cost of replacing one jersey is \$70.00. Parents will need to provide black shorts, shin guards, royal blue soccer socks, and cleats.

Fee: Each player will be charged a \$34.00 sport's fee. Please do not send payment with this permission slip. You will be billed with your November tuition payment.

Academic Eligibility: Students become ineligible for games and practices if they do not meet academic eligibility (see handbook). **Players not academically eligible by lunch time on practice and game days will not be able to participate and will phone home so that parents can pick them up at the end of the school day.**

The following permission slip, along with a concussion form, must be turned in to the Mrs. Enstad before a student may participate in any games or practices. The deadline to sign up for the team is **September 22.**
